Beginning of School Year

- **STUDENTS BEGINNING 9TH GRADE OR BELOW:** Students must have been promoted from the previous grade.
- **STUDENTS BEGINNING 2ND YEAR OF HIGH SCHOOL:** Two and a half accumulated credits that count toward state graduation requirements.
- **STUDENTS BEGINNING 3RD YEAR OF HIGH SCHOOL:** Ten accumulated credits that count toward state graduation requirements or student must have earned at least two and a half credits within the last twelve months that count toward state graduation requirements.
- **STUDENTS BEGINNING 4TH YEAR OF HIGH SCHOOL:** Fifteen accumulated credits that count toward state graduation requirements or students must have earned at least two and a half credits within the last twelve months that count toward state graduation requirements.

End of 1st 6-weeks	Friday, October 16	Check grades of all students.
	Friday, October 23	Lose or gain eligibility based on 1 st 6-week report.
3-week evaluation period	Friday, November 6	Check grades of ineligible students.
	Friday, November 13	Gain eligibility if passing all classes.
Thanksgiving Break	Friday, November 20	Students ineligible prior to Thanksgiving Break are eligible after school on Friday, November 20 to Saturday, November 28.
	Friday, November 30	Students ineligible prior to Thanksgiving Break go back to being ineligible.
End of 2nd 6-weeks	Friday, December 4	Check grades of all students.
	Friday, December 11	Lose or gain eligibility based on 2 nd 6-week report.
Winter Break	Friday, December 18	Students ineligible prior to Winter Break are eligible after school Friday, December 18 to Tuesday, January 5.
	Wednesday, January 6	Students ineligible prior to Winter Break go back to being ineligible.
3-week evaluation period	Friday, January 8	Check grades of ineligible students.
	Friday, January 15	Gain eligibility if passing all classes.
End of 3rd 6-weeks	Friday, January 29	Check grades of all students.
	Friday, February 5	Lose or gain eligibility based on 3 rd 6-week report.
3-week evaluation period	Monday, February 22	Check grades of ineligible students.
	Monday, March 1 (see * below)	Gain eligibility if passing all classes.
End of 4th 6-weeks Spring Break	Friday, March 12	Students ineligible prior to Spring Break are eligible after school Friday, March 12 to Saturday, March 20.
	Monday, March 22	Students ineligible prior to Spring Break go back to being ineligible.
3-week evaluation period	Friday, March 26	Lose or gain eligibility based on 4 th 6-week report.
	Monday, April 5	Check grades of ineligible students.
	Monday, April 12	Gain eligibility if passing all classes.
End of 5th 6-weeks	Friday, May 7	Check grades of all students.
	Friday, May 14	Lose or gain eligibility based on 5 th 6-week report.
3-week evaluation period	Friday, May 28	Check grades of ineligible students.
	Friday, June 4	Gain eligibility if passing all classes.

**If February 15 is a school day, ineligible students can gain eligibility Friday, February 28, if passing all classes.*
